Application Guide

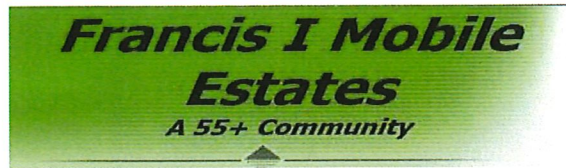
1. Everyone and anyone who will own a home/ property or reside in Francis I must complete an application. 2 people maximum per home.
2. Submit your completed application(s) to the Francis I office.
3. Proof of pet breed is required with your application. Registration will be completed upon approval.
4. Copy of valid ID is required for all applicants
5. Cost per person is \$50.00 (US Citizen) or \$100.00 (Canadian Citizen). This transaction is payable by check or money order only.
6. Your application(s) will be sent electronically to Professional Screening Services, Inc. (407) 706-6909. Professional Screening Services, Inc. will conduct the background screening and send the results back electronically.
7. Once the results are received, your SSN(s) will be blocked out from all forms.
8. Your application(s) and background result(s) will then be submitted to the Approval Committee. The Approval Committee is made up of 3 appointed Board Members. It will take 3-5 business days for their decision.
9. If you are approved, an office employee will call you to notify you of the good news. If you are denied, a letter of denial will be mailed to the address provided.

Board Resolution: Effective 1/1/2026

Be it resolved, at the Joint Board Meeting held December 15, 2025, hereby adopted the following financial and background guidelines that must be met or exceeded by any potential purchaser of a home, land or share in Francis I Mobile Estates or resident prior to the transaction, lease or rental agreement being completed.

- At least one owner and/or resident must be fifty-five (55) years old or older and the other owner and/or resident must be a minimum of forty-five (45) years old. Someone under fifty-five (55) years old may not reside in any unit without a co-habitant that meets or exceeds the age requirement.
- Must have a credit score of **700** or higher on the FICO Score Guideline chart (below) to be approved for ownership.

700-799 VERY GOOD

680-699 GOOD

620-679 OK

500-579 BAD

300-499 POOR

- All potential owner(s) and/or owner-resident co-habitants must have a household income of \$2,000.00 per month. The income requirement will increase annually in accordance with the CPI percentage.

All potential owners and/or residents must pass the following criminal background requirements:

- No convictions of/relating to violence, either misdemeanor or felony, ever.
- No convictions of/relating to fraud or theft, either misdemeanor or felony, ever.
- No convictions of/relating to drugs or drug paraphernalia, either misdemeanor or felony, ever.
- No convictions of/relating to sexual predator/offender, human trafficking or prostitution, ever.
- No evictions, ever.
- No more than two (2) misdemeanor convictions, not of/relating to those listed above, in the last twenty (20) years.
- No felony convictions, not of/relating to those listed above, in the last twenty (20) years.

All applicants must read the documents provided with the application and sign affirming that they understand and will abide by the Rules & Regulations of our community.

A committee made up of three (3) Directors will review applications and backgrounds to determine if the applicant(s) is approved or denied. The applicant(s) have the right to appeal the committee's decision within thirty (30) days. Appeals must be submitted to the Francis I office, in writing and signed by the applicant(s). The applicant(s) may submit additional supporting/relevant documents with the appeal. The committee will review the application, additional documents and the appeal letter to come to a decision. The applicant(s) then have the right to appeal the committee's appeal decision to the entire Board of Directors should the applicant(s) disagree with the outcome of the first (1st) appeal. This appeal must also be submitted to the Francis I office, in writing and signed by the applicant(s).
